Terms of Service – Cyber Troopers

5. Leads and Prospect Data

Leads sold on Cyber Troopers are intended for telemarketing to help you grow your MLM business. We do not guarantee sales or results. You should expect a portion of the leads to contain disconnected numbers, wrong numbers, or unresponsive individuals.
